Area shall be limited to individuals or firms located within or immediately adjacent to the Sacramento River North Delta region along highway 160, to be generally encompassed by the following boundary: North Boundary: City of Sacramento, West Boundary: Deep Water Channel & Rio Vista, East Boundary: Interstate 5 & Thornton, South Boundary: Highway 4.
  - b) Associate Membership: (Non-Voting) Any business, association, or community-oriented group/organization that wants to benefit from membership and show support for the Delta Farm & Winery Trail.
