Farm Trail Membership Application

1. The primary activity of the Delta Farm & Winery Trail shall be the educating of the public in conjunction with marketing of agricultural products from the Sacramento River Delta area.
2. Qualifications
 - a) Farm Trail Membership: (Voting) Any individual or firm that is a producer and provides for public access to experience any agriculturally related endeavor (farmer, rancher, winery, nursery, environmental/nature, manufacturer). Area shall be limited to individuals or firms located within or immediately adjacent to the Sacramento River North Delta region along highway 160, to be generally encompassed by the following boundary: North Boundary: City of Sacramento, West Boundary: Deep Water Channel& Rio Vista, East Boundary: Interstate 5 & Thornton, South Boundary: Highway 4.
 - b) Associate Membership: (Non-Voting) Any business, association, or community-oriented group/organization that wants to benefit from membership and show support for the Delta Farm & Winery Trail.
3. Signs are solely owned by the Sacramento River Delta Grown Agri-Tourism Association and use is revocable upon termination of membership. Farm Trail Members can choose between either size:
 - a) Large 36x42" double sided roadside Delta Grown logo sign and farm identification sign with farm name and trail number with sign posts.
 - b) Small 12x18" double sided roadside Delta Grown logo Farm Trail sign with farm number (to attach to current business road sign)
4. Farm Trail Founding Memberships are no longer available for purchase.
